CLUB CONSTITUTION**

ARTICLE I
NAME AND PURPOSE

SECTION A - The name of the organization is "Marine City High School Athletic Booster Club."

SECTION B - The purpose of the Marine City High School Athletic Booster Club are:

1. To foster a high degree of enthusiasm, recognition and support of the Varsity athletic and related programs of the Marine City High School, with the support of the student body, faculty, administration, alumni, business community and general public.
2. To encourage above average academic performances, sportsmanship and citizenship by participants of these programs.
3. To assist in the improvement of existing or the procurement of new facilities and equipment by means of financial, manpower, material, technical or other manners of support.
4. To promote and encourage interest among its members in the administrative programs and proceedings of the Marine City High School and the East China School District.

ARTICLE II
MEMBERSHIP

SECTION A - Any person eighteen (18) years of age, or older, who has an interest in the development of Marine City athletics.

SECTION B - Conditions of membership:

1. Membership is attained by regular attendance and payment of dues.
2. Membership is renewed each year.

SECTION C - Membership dues:

1. Membership is attained by payment of one dollar per year.
2. Dues are payable at time of joining the Booster Club and each September thereafter.

SECTION D - A simple majority of "registered members" present, constitutes a quorum.

SECTION E - "Robert's Rules of Order", Revised Edition, will be the parliamentary authority for meetings of this organization - subject to special rules consistent with customs and practices of the Booster Club.

ARTICLE V
AMENDMENTS

SECTION A - Amendments to this constitution may be submitted for vote after expiration of a minimum of thirty (30) calendar days from completion of discussion on a seconded motion.

SECTION B - Public notice announcing the meeting and describing the subject amendment will be disclosed to the general membership two weeks prior to the meeting.

SECTION C - A constitution amendment will require the affirmative vote of the majority of "registered members."

SECTION D - That upon dissolution of organization, all remaining assets will revert to the school.

THE MARINE CITY HIGH SCHOOL ATHLETIC BOOSTER CLUB BY-LAWS

SECTION A - FINANCES

1. The President, Vice-President and Treasurer are responsible for the bank account.
2. Expenditures need to be approved by general membership majority vote prior to disbursement.
3. Special project requests should:
 - A. Written requests on the approved form will be channeled through the school administration (Athletic Director) before presented to the Booster Club. All requests of \$500.00 or more will require three written estimates.
 - B. If a project is brought directly to a general meeting, it must be tabled for discussion by the membership.
 - C. Should a request from the Athletic Department need immediate attention, the president shall have authority, after polling the other three officers, for expenditures not to exceed \$700.00. All other requests must have the general membership polled.

4. Meal allowances for teams and individuals participating in State level competition.

A. Teams (5 or more players) \$5.00 per player per day of consecutive play not to exceed \$300.00.

B. Individual (1-4 players) \$10.00 per player for one day competition, \$25.00 for overnight for two days of consecutive play.
